In 1996, the VCPPOA was incorporated as a 501(c) (5) organization; and

WHEREAS, VCPPOA MEMBERS ARE DEDICATED TO PROVIDING PROFESSIONAL, CRITICAL PUBLIC SAFETY SERVICES TO THE CITIZENS AND BUSINESSES OF VENTURA COUNTY; AND

WHEREAS, THE VCPPOA CREATED ITS 501(C) (3) CHARITABLE FOUNDATION IN 2009, AND ITS MEMBERS TAKE PRIDE IN GIVING BACK TO OUR COMMUNITY THROUGH VOLUNTARY SERVICE AND FINANCIAL CONTRIBUTIONS. WITHIN THE FOUNDATION, A FALLEN OFFICERS FUND IS AVAILABLE TO SUPPORT AND ASSIST THE FAMILIES OF FALLEN PEACE OFFICERS, WHETHER DECEASED OR SERIOUSLY ILL.
