THIS CONTRACT for the services of the music and/or entertainment described below made this ___th day of _____, 2_____, between the undersigned Purchaser/Venue of music and/or entertainment (hereinafter called the Purchaser) and the undersigned Artist(s) (plus any accompanying musicians and/or entertainers) as described below, an independent contractor(s), (hereinafter called the "Artist").

breaks may vary in occurrence and/or duration due to unforeseen circumstances at the function or due to instructions from the bar manager/booking manager

THE PURCHASER shall at all times have complete supervision, direction, and control over the services of Artist(s) on this engagement and expressly reserves the right to control the manner, means, and details of the performance of the services by Artist as well as the ends to be accomplished. The leader shall, as agent of the Purchaser, enforce disciplinary measures for just cause, and carry out instructions as to the selection and manner of performance.

THE ARTIST, leader, manager, or representative of the Artist(s) agrees and guarantees to pay 50% percent of food purchases and carry a bar tab that does not exceed \$_____. **THE AGREEMENT** of the Artist to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control.

THIS CONTRACT constitutes the sole, complete, and binding agreement between the Artist(s) and the Purchaser. Covenants herein contained between said Artist(s), their leader, manager or representative and AGENT are intended to be binding as between said Artist(s), their leader, manager or representative and AGENT.

PHOTOGRAPHY AND RECORDINGS of said performance may be used by purchaser for future marketing, website marketing or any event pertaining to the image and representation of Bar of America.

ADDITIONAL TERMS AND CONDITIONS:

- *Property of bar of America will not be used for props or other stage set-up needs (chairs and tables)
- *All cables will be securely fastened to the floor with Gaffers tape (NOT DUCT TAPE!)
- *Three(3) Feet of Clearance will be left on the side and behind the stage for wheel chair access to the handicap restroom
- *Merchandising will be placed in the front of the bar on a fold out table provided by Purchaser
- *Parking is on a first come first served basis. Parking is enforced until 6pm. We will cover parking costs during the unloading of equipment.
